

TERMS AND CONDITIONS FOR GROUP USERS: These terms and conditions are issued by Icehouse Melbourne Operations Pty Ltd (**Supplier**) and apply to all groups using the facilities at the Icehouse at 105 Pearl River Road, Docklands, Victoria (**Icehouse**), including sporting or social clubs and associations, school and community groups, corporate events and children's parties (**Groups**).

1. A representative (**You**) of a Group that wishes to use the Icehouse must sign and return a copy of these Terms and Conditions for Group Users to the Supplier before the Group uses the facilities and equipment at the Icehouse.
2. You represent and warrant that you are an authorised representative of, or person responsible for, Your Group and can sign these Terms and Conditions for Group Users on behalf of each member of Your Group.
3. These Terms and Conditions for Group Users apply in addition to the Icehouse Standard Terms and Conditions of Use, which will continue to apply to each user of the facilities and equipment at the Icehouse. Failure to return a signed copy of these Terms and Conditions for Group Users to the Supplier will not affect, in any way, the application of the Standard Terms and Conditions of Use to each member of Your Group.
4. You acknowledge that ice skating, ice skating lessons, speed skating, figure skating, ice hockey, curling, broomball, use of the gym facilities and equipment and other sporting and recreational activities at the Icehouse are dangerous and involve a significant degree of physical exertion and risk. You also acknowledge that the facilities may be unsupervised and that Your Group and its members participate in these activities at their own risk. If any member of Your Group does not currently undertake regular physical activity, they should obtain medical advice before using the Icehouse facilities and equipment.
5. Your Group is responsible for ensuring they use the facilities and equipment at the Icehouse in a safe manner and do not create risks and hazards for other users.
6. All members of Your Group must be at least 12 years of age to use the ice rink and at least 16 years of age to use the gym at the Icehouse, unless supervised by a responsible adult. Where members of Your Group are below these age limits, You agree that You are responsible for their safe use of the facilities and equipment at the Icehouse and that you will directly supervise them at all times.
7. You must ensure that Your Group complies with all signs or other directions of the Supplier. The Supplier may, at its absolute discretion, suspend or ban a Group from access to any or all facilities and equipment at the Icehouse for non-compliance or for reckless or careless conduct.
8. You agree that you will provide or offer a copy of the Icehouse Standard Terms and Conditions of Use to all members of Your Group or their parent or guardian. A copy of the Standard Terms and Conditions of Use will be provided with these Terms and Conditions for Group Users, and is also available from the Icehouse front desk and the website.
9. You agree that Icehouse has no obligation to indemnify Your Group (or its related entities) for any claim brought by its members in connection with their use of the Icehouse.
